Mayor Schmitt called the meeting to order at 8:05 pm and performed roll call.

Mayor Schmitt announced that there is a new commissioner, Commissioner Geoff Baker is the new Landscaping Commissioner, but he is unable to attend the meeting tonight.

The July 2022 meeting minutes were reviewed. Mayor Schmitt made a motion to approve the July 2022 minutes. Commissioner White seconded the motion. The council voted and the July 2022 minutes were unanimously approved.

Police Crime Report presented by Mr. Schwab. Mr. Schwab emailed the monthly crime report. There were no crime reports in December. Mayor Schmitt asked Mr. Schwab about Flock security cameras. Mr. Schwab reports that Mockingbird Valley is getting quotes for the Flock cameras. Indian Hills, the Temple, and Jeffersontown have several Flock cameras in use. He states that the Flock cameras detect car license plates, colors, and types.

Mayor's Report by Mayor Schmitt. Mayor Schmitt announced that the Certificates of Election have been received. All elected commissioners have been sworn in. He notes that there is still one more commissioner seat to fill. Mayor Schmitt reported that a tree fell on the north side of the Lime Kiln Lane access road at Glen Hill Road, and he sawed the limbs obstructing access to the Lime Kiln Lane access road. He contacted Metro Louisville to remove the remainder of the tree that was located on Metro's right of way.

Streets and Drainage Report by Commissioner White. Commissioner White reports that the Glenview Avenue MSD project is under contract. Wes is the contact for MSD. She reports that LawnPro plowed

the City for snow during December. She has forwarded the invoice to Treasurer Willis for payment to be made.

Lights, Signs, and Insurance Report by Commissioner Wilson. Commissioner Wilson reports that she has a meeting with Booker Design this week.

Treasurer Report by John Willis. Treasurer Willis reports that there were two landscaping invoices paid in December. He is catching up on payroll payments. He reviewed the monthly bank statements. He and Mayor Schmitt have a meeting on Friday at PNC Bank with Tanya the bank manager.

Clerk Report by Katie Schmitt. Clerk Schmitt has no updates.

Attorney Report by Abigail Green. Attorney Green is planning on updating the website. She requested the missing minutes from Clerk Schmitt. She also requested any updated profile pictures or email addresses for the website updates.

Landscaping Report by Commissioner Geoff Baker. Geoff Baker is absent and does not have a report at this time.

Law Enforcement and Sanitation Report by Commissioner. There is no commissioner as this position is vacant at this time.

Jefferson County League of Cities Report. There is no representative as this position is vacant at this time.

Mayor Schmitt received a call from the owner of the cabin property on Cabin Way. The owner discussed two options for the cabin property which are moving the cabin to Woodford County or making the cabin property a stop on the Bourbon Trail. Mayor Schmitt noted that the Council is against Short Term Rentals. He proposed that the City needs an Ordinance against Short Term Rentals. Attorney Green stated that she will discuss this with colleagues and request an example of a short term rental ordinance.

Mayor Schmitt adjourned the meeting at 8:40 pm.
