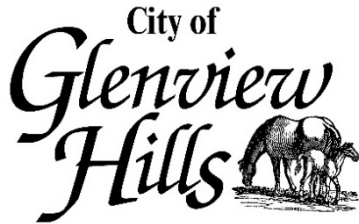
SANITATION

We just recently renewed our contract with Rumpke. As a result, we are excited to announce that we will now have a third "Junk Pick Up" day in 2024.

2024 Junk Dates:

1. March 25th
2. June 24th
3. September 23rd

As a reminder, our contract with Rumpke includes rear door service for garbage only. Please note, this only applies to 3-30 gallon cans. If you have a regular 95 gallon brown can, residents will need to wheel it to the curb for pick up. Recycling and yard waste also need to be brought to the curb/street. As we move into fall, a quick reminder that leaves/yard waste is picked up on Mondays, and should be placed in the brown leaf bags. Please do not place yard waste in the brown/green cans provided by Rumpke. Remember the junk dates and waste guidelines are also listed on the Glenview Hills website under the *Resources* tab if you need a reminder or reference.
